RE: Traffic Violations Bureau Order
EFFECTIVE May 21, 2018



ADMINISTRATIVE ORDER NO. 18- H

WHEREAS, O.C.G.A §40-13-50 provides for the establishment of a Traffic Violations Bureau, and

WHEREAS, it is the desire of this Court to provide for the prompt disposition of the traffic cases assigned to this Court;

IT IS THEREFORE ORDERED that, effective May 21, 2018, all prior versions of the Traffic Violations Bureau Order and amendments thereto shall be deleted in their entirety and replaced with the following:

Section 1. The Traffic Violations Bureau shall be under the direct supervision of and attached to the office of the Clerk of State Court. The Clerk of State Court and any assistants he or she requires are hereby appointed to receive the fines and forfeitures as specifically set out herein. The State Court Judges, the Solicitor General, the Clerk, the Sheriff of Forsyth County and any other law enforcement agencies issuing citations within the jurisdiction of and answerable to the State Court of Forsyth County shall work together to establish and/or modify administrative procedures, case management system requirements and procedures and such other matters as may be necessary to comply with all applicable statutes and court rules and to effect the efficient operation of the Traffic Violations Bureau in the State Court.

Section 2. The offenses designated herein in the attached Exhibits "A" and "B" are payable under the Traffic Violations Bureau in the amount equal to the fine plus all applicable surcharges required by statute without the requirement of a court appearance, with the exception

that any case involving an accident shall not be assigned to the Traffic Violations Bureau. If a defendant chooses to pay a scheduled fine without a court appearance, the citation shall serve as the accusation. Defendants who are cited for offenses assigned to the Traffic Violations Bureau shall be assigned a traffic arraignment date based on a schedule provided by the State Court.

Section 3. Offenses which are not listed in the attached Exhibits "A" and "B" and for which a defendant is issued a citation but not arrested, shall require a court appearance by the defendant on the next available "bonded arraignment" date, as provided by the Court, for that defendant based on the incident date on the citation.
